RULES & ENTRY FORM

RULES

PRE-RACE

Raft Race day,

1. Entry forms will be available before event and on beach location on day of event
2. Raft captains are to check in with beach event officer
3. After registration, complete rafts must be taken to the beach for placement, inspection and judging etc.
4. **£10 per raft entry fee.** Late arrivals to sign forms on beach if necessary

GENERAL RULES

1. The minimum number of crew is 2 The raft must have all crew on board when finishing
2. Crew members must not receive assistance from the shore or any other vessel, e.g. No towing.
3. Competitors are requested to use suitable dress/protective clothing so as to conserve body heat.
4. Start and finishing instructions will be issued to raft captains when registering entries at the registration station.
5. Minimum age of entrants, 15 years. Under 18 year olds must have the signed permission of a parent or guardian and they must be accompanied on the raft by an adult.
6. In all matters relating to the Raft Race the Committee's decision is final

RAFT CONSTRUCTION RULES

1. Rafts should be strongly constructed and capable of withstanding sea conditions.
2. A raft must be capable of being carried by the crew of the raft.
3. Rafts must not be modified from normal marine craft or other waterborne craft.
4. Paddles are permitted.
5. No form of rowing will be permitted.
6. No type of engine propulsion is allowed. However, rafts can be paddled, sailed, swim towed, or driven by human mechanical power. Rafts can not be pushed by wading in the water.
7. Construction of rafts and equipment should be safe, e.g. No protruding nails or screws, sharp metal edges etc.

SAFETY RULES

The decision on whether to go ahead with this event, and how it is to be run, lies entirely with the Abersoch RNLI Station. Sea conditions, wind strength and direction, wind chill, pollution etc. will all be taken into account before any decisions are made.

1. Any craft, because of its construction is considered to be a danger to other competitors will be held back at the start of the race.
2. Competitors are reminded that the ramp-way on to the beach at the SCYC end is steep and crews carrying a raft should exercise due care if accessing the beach in this way.
3. Well fitting, recognised life preserving devices or approved buoyancy aids must be worn by all competitors – there will be no exception to this rule. The wearing of a canoe helmet is also recommended.
4. No physical interference between rafts will be permitted and offending crews may be disqualified.
5. Safety craft will be provided. It is, however, the responsibility of each raft captain to ensure the safety of his/her crew, so to satisfy themselves that all crewmembers are proficient swimmers. Raft captains will be required to sign a declaration to that effect. Raft captains will also be responsible for drawing to the attention of the organisers, any crewmember with a medical condition, disability or special needs.
6. Competitors must follow the instructions of the safety officials on the beach and in safety boats. Safety officials are permitted to withdraw from the race any crewmembers who they consider to be unfit to participate or to continue.
7. In the interests of safety, all rafts/debris must be removed from the water and surrounding areas at the end of the race. Non-compliance with this rule will disqualify from future races.

GENERAL DECLARATION TO BE SIGNED BY ENTRANTS

All participants will be required to sign that they have read and accept the RNLI's Terms and Conditions before being allowed to participate in the race.

RACE RULES

COURSE

1. The race will start at approx 18.30 hrs from Abersoch Main Beach
2. Prior to the start rafts shall be placed next to the water's edge. Crews shall retire from the water and start 'Le Mans' style on hearing the klaxon.
3. The course will be a triangular course around three buoys in the bay.

DATE and TIME

Thursday 15th August at 18:30 hrs

TIDAL INFORMATION

High water 17.18 hrs approximately.

VENUE

Registration is at the bottom of the ramp in the centre of Abersoch Main Beach.
The course is in Abersoch bay, off the Main beach
The direction and length of the course is weather dependent.

EVENT TERMS AND CONDITIONS

The Participant may at its sole discretion choose to grant the RNLI consent. It is not a condition of the Event that such consent is granted.
- 1.6. All Participants and the parents or guardians of any under 18's acknowledge and agree that no payment will be made to any Participant for the use of any photographs, images or films in which they may feature.
- 1.7. The RNLI's use of the Participant's photograph and/or personal information contained in a marketing feature will be in accordance with the RNLI's privacy and cookies policy which can be found at <https://rnli.org/footer/privacy-and-security>.
- 1.8. Please note that participating in certain RNLI events may involve a real risk of serious injury or even death from over exertion, dehydration, accidents with other participants, spectators or road or sea users and other causes.

We recommend that you obtain personal accident insurance cover for any activity involving risk of injury.
3. If a claim is made against the RNLI in relation to the activity (except where the activity has been organised by the RNLI) or arising out of any breach by you of these terms and conditions, you agree to reimburse the RNLI for any sums which the RNLI pays as a result of that claim including, but not limited to, any associated legal or other costs and expenses.
4. You agree to make clear that you are raising funds in aid of the RNLI and will not indicate or imply that you represent the RNLI.

6. RULES

PRE-RACE

Raft Race day,

5. Entry forms will be available before the event and on the beach location on day of the event
6. Lead parents are to check in with the beach event officer
7. After registration complete rafts must be taken to the beach for placement, inspection, judging etc.
8. **£5 per raft entry fee.** Late arrivals to sign forms on the beach if necessary

GENERAL RULES

1. The minimum number of crew is 2. The raft must have all crew on board when finishing
2. Crew members must not receive assistance from the shore or any other vessel. e.g. No towing.
3. Competitors are requested to use suitable dress/protective clothing so as to conserve body heat.
4. Start and finishing instructions will be issued to raft captains when registering entries at the registration station.
5. Minimum age of entrants, 6 years. At the time of registration, a parent or guardian must sign a disclaimer stating that the child is in good health and able to swim.
6. Each parent or guardian will be a spotter for their child during the race, i.e. keep an eye on their well-being.
7. In all matters relating to the Raft Race the Committee's decision is final

9. A raft must be capable of being carried by the parents of the crew of the raft.

13. No type of engine propulsion is allowed. However, rafts can be paddled, sailed, swim towed, or driven by human mechanical power. Rafts can not be pushed by wading in the water.

10. No physical interference between rafts will be permitted and offending crews may be disqualified.
11. Safety craft will be provided. However, parents / guardians of the children are to follow the race and keep an eye on their respective children and raise the alarm with the nearest marshal if they believe that their child is in danger.
12. Competitors must follow the instructions of the safety officials on the beach and in safety boats. Safety officials are permitted to withdraw from the race any crewmembers who they consider to be unfit to participate or to continue.
8. In the interests of safety, all rafts/debris must be removed from the water and surrounding areas at the end of the race. Non-compliance with this rule will disqualify from future races.
8. All the land around the race area is designated as an “Alcohol Free” zone.
